Transplants are not regarded as propagating material and requirements for transplants are described in standard 2.7.8.</u></p>	<p>This is a technical revision to clarify what is meant by 'propagating material' and 'transplants'.</p>
<p>2.7.4 Using non-organic seed and vegetative propagating material (Baseline)</p>	<p>The guidance is updated as follows: <u>You do not require prior approval when sowing grass/forage/arable silage/whole crop silage/cover crop green manure mixes that contain at least 70% (by weight) organic seeds as long as you provide details of these on the Annual Questionnaire we will send you before your inspection.</u></p>	<p>This update is to enable the collection of data required for reporting to NICA.</p>
<p>2.8.1 – Substrates for mushroom production (SA higher standard)</p>	<p>As above, the guidance is amended as follows: We are aiming to phase out the use of peat by 2025. <p>3.17.14 – Exceptional rules for Beekeeping due to catastrophic circumstances</p> <p>(SA higher standard)</p>	<p>The standard is amended as follows:</p> <p>[...]</p> <p>3. With the approval of your competent authority, where the survival of the colony is endangered for other reasons than climatic conditions, bee colonies may be fed with organic honey, <u>organic pollen</u>, organic sugar syrups, or organic sugar.</p>	<p>This amendment brings the NI standard in line with the EU regulation (2018/848) (as above for standard 3.17.13) which permits the feeding of organic pollen to bees.</p>
